2.3. Other hazards (not relevant for classification)

Other hazards not contributing to the classification

: This product is combustible, but not classified as Flammable. The creation of flammable vapour mixtures takes place at temperatures which are higher than normal ambient levels. : In case of disturbances owing to inhalation of vapours or mists, remove the victim from exposure; keep at rest; if necessary, seek medical attention. See also section 4.3.

: Take off contaminated clothing and shoes. Wash thoroughly with soap and water. If skin irritation or rash occurs, get medical advice/attention. In case of contact with hot product, cool affected part with plenty of cold water, and cover with gauze or clean cloth. Call a doctor or bring to an hospital. Do not use salves or ointments, unless directed by doctor. Body hypothermia must be avoided. Do not put ice on the burn.

4.2. Most important symptoms and effects, both acute and delayed

Symptoms / injuries (general indications)

Symptoms/effects after inhalation

: Not expected to present a significant hazard under anticipated conditions of normal use.

: This product has a low vapour pressure, and in normal conditions at ambient temperature the concentration in the air is negligible. A significant concentration may build up only if the product is used at high temperature, or in case of sprays and mists. In these cases overexposure to vapours may cause irritation to airways, nausea and dizziness.

4.3. Indication of any immediate medical attention and special treatment needed

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media

: Small-size fires: carbon dioxide, dry chemicals, foam, sand or earth. Large fires: foam or water fog (mist). These means should be used by trained personnel only. Other extinguishing gases (according to regulations).

5.3. Advice for firefighters

Protective equipment
