SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures general

: In case of spontaneous vomiting, transport the victim to a hospital, to verify the possibility that the product has been aspired into the lungs.

First-aid measures after inhalation

Inhalation is unlikely because of the low vapour pressure of the substance at ambient temperature. Exposure to vapours may however occur when the substance is handled at high temperatures with poor ventilation. In case of symptoms arising from inhalation of product fumes, mists or vapour: Remove person to fresh air and keep comfortable for breathing. If casualty is unconscious and not breathing: ensure that there is no obstruction to breathing and give artificial respiration by trained personnel. If necessary, give external cardiac massage and obtain medical advice. If the casualty is breathing: Place in the recovery position. Administer oxygen if necessary. See also section 4.3.

First-aid measures after skin contact

: Take off contaminated clothing and shoes. Wash thoroughly with soap and water. Seek medical attention if skin irritation, swelling or redness develops and persists. In case of contact with hot product, cool affected part with plenty of cold water, and cover with gauze or clean cloth. Call a doctor or bring to an hospital. Do not use salves or ointments, unless directed by doctor. Body hypothermia must be avoided. Do not put ice on the burn. DO NOT attempt to remove portions of clothing glued to burnt skin but cut round them.

First-aid measures after eye contact

: Rinse eyes thoroughly for at least 15 minutes. Keep eyelids well apart. Remove contact lenses, if present and easy to do so. If irritation, blurred vision or swelling occurs and persists, obtain medical advice from a specialist. In case of contact with hot product, cool affected part with plenty of cold water, and cover with gauze or clean cloth. Call a doctor or bring to an hospital. Do not use salves or ointments, unless directed by doctor. Immediately obtain specialist medical assessment and treatment for the casualty.

First-aid measures after ingestion

: Do not induce vomiting to avoid aspiration into the lungs. If the person is conscious, rinse mouth with water without swallowing. Keep at rest. Call for medical assistance or bring to an hospital. If the casualty is inconscious, place in the recovery position. In case of spontaneous vomiting, keep head low, to avoid the risk of aspiration into the lungs. Do not give anything by mouth to an unconscious person.

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects after inhalation

: This product has a low vapour pressure, and in normal conditions at ambient temperature the concentration in the air is negligible. A significant concentration may build up only if the product is used at high temperature, or in case of sprays and mists. In these cases overexposure to vapours may cause irritation to airways, nausea and dizziness.

Symptoms/effects after skin contact Symptoms/effects after eye contact : Contact with hot product may cause thermal burns.

Symptoms/effects after ingestion

: Contact with eyes may cause a light transient irritation. Contact with hot product or vapours may cause burns.

Symptoms/effects upon intravenous administration Chronic symptoms

: Swallowing the liquid may cause aspiration into the lungs with the risk of chemical pneumonitis. May be harmful if swallowed and enters airways. The effects may be delayed.

4.3. Indication of any immediate medical attention and special treatment needed

Obtain medical attention if casualty has an altered state of consciousness or if symptoms do not resolve. In case of ingestion, always assume that aspiration has occurred. Send the casualty immediately to hospital. Seek medical attention in all cases of serious burns. If there is any suspicion of inhalation of H2S (hydrogen sulphide). The casualty should be sent immediately to hospital. Immediately begin artificial respiration if breathing has ceased. Administer oxygen if necessary.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media

: Small-size fires: carbon dioxide, dry chemicals, foam, sand or earth. Large fires: foam or water fog (mist). These means should be used by trained personnel only. Other extinguishing gases (according to regulations).

Unsuitable extinguishing media

: Do not use water jets. They could cause splattering, and spread the fire. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam.

5.2. Special hazards arising from the substance or mixture

Fire hazard

: This product is combustible, but not classified as Flammable. The creation of flammable vapour mixtures takes place at temperatures which are higher than normal ambient levels.

Explosion hazard

: In case of losses from pressurized circuits, the sprays may form mists. Take into account

that in this case the lower explosion limit for mists is about 45 g/m3 of air.

Hazardous decomposition products in case of fire

: Incomplete combustion will generate poisonous carbon monoxide, carbon dioxide and other toxic gases. Combustion products include sulphur oxides (SO2 and SO3) and Hydrogen sulphide H2S. Oxygenated compounds (aldehydes, etc.).

5.3. Advice for firefighters

Firefighting instructions

: Shut off source of product, if possible. Move undamaged containers from immediate hazard area if it can be done safely. Spilled product which is not burning should be covered with sand or foam. Use water sprays to cool containers and surfaces exposed to the flames. If the fire cannot be controlled, evacuate area.

Special protective equipment for firefighters

Personal protection equipment for firefighters (see also sect. 8). In case of a large fire or in confined or poorly ventilated spaces, wear full fire resistant protective clothing and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode. EN 443. EN 469. EN 659.

Other information

: In case of fire, do not discharge residual product, waste materials and runoff water: collect separately and use a proper treatment.

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

General measures

: Stop or contain leak at the source, if safe to do so. Eliminate all ignition sources if safe to do so (e.g. electricity, sparks, fires, flares). Avoid direct contact with released material. Keep upwind.

6.1.1. For non-emergency personnel

Protective equipment

: See Section 8.

Emergency procedures

: Avoid direct contact with released material. Keep non-involved personnel away from the area of spillage. Alert emergency personnel. Except in case of small spillages, the feasibility of any actions should always be assessed and advised, if possible, by a trained, competent person in charge of managing the emergency.

6.1.2. For emergency responders

Protective equipment

: Small spillages: normal antistatic working clothes are usually adequate. Large spillages: full body suit of chemically resistant and antistatic material. if necessary heat resistant and insulated. Work gloves providing adequate chemical resistance, specifically to aromatic hydrocarbons. Gloves made of PVA are not water-resistant, and are not suitable for emergency use. If contact with hot product is possible or anticipated, gloves should be heat-resistant and thermally insulated. Antistatic non-skid safety shoes or boots, chemical resistant. Work helmet. Goggles and /or face shield, if splashes or contact with eyes is possible or anticipated. Respiratory protection: A half or full-face respirator with filter(s) for organic vapours (A) (or A+B when applicable for H2S), or a Self-contained Breathing Apparatus (SCBA) can be used according to the extent of spill and predictable amount of exposure. A Self Contained Breathing Apparatus (SCBA) can be used according to the extent of spill and predictable amount of exposure. If the situation cannot be completely assessed, or if an oxygen deficiency is possible, only SCBA's should be used.

Emergency procedures

: Notify local authorities according to relevant regulations.

6.2. Environmental precautions

Do not let the product accumulate in confined or underground spaces. Do not let the product flow into sewers or water courses, or in any way contaminate the environment. In case of contamination of environment compartments (soil, subsoil, surface or underground waters), remove contaminated soil when possible, and in any case treat all involved compartments in accordance with local regulations. The site should have a spill plan to ensure that adequate safeguards are in place to minimize the impact of episodic releases.

6.3. Methods and material for containment and cleaning up

For containment

: Contain spilled liquid with sand, earth or other suitable absorbents (non-flammable). Recover free liquid and waste materials in suitable waterproof and oil-resistant containers. Clean contaminated area. Dispose of according to local regulations. Large spillages may be cautiously covered with foam, if available, to limit fire risk. When inside buildings or confined spaces, ensure adequate ventilation. Absorb spilled product with suitable non-combustible materials. Collect free product with suitable mechanical means. Transfer collected product and other contaminated materials to suitable containers for recovery or safe disposal. If in water: In case of small spillages in closed waters, contain product with floating barriers or other equipment. Collect spilled product by absorbing with specific floating absorbents. If possible, large spillages in open waters should be contained with floating barriers or other suitable mechanical means. If this is not possible, control the spreading of the spillage, and collect the product by skimming or other suitable mechanical means. Collect recovered product and other materials in suitable tanks or containers for recovery or safe disposal. Do not use solvents or dispersants, unless specifically advised by an expert, and, if required, approved by local authorities.

Other information

Do not use solvents or dispersants, unless specifically advised by an expert, and, if required, approved by local authorities. Recommended measures are based on the most likely spillage scenarios for this material; however, local conditions (wind, air/water temperature, wave/current direction and speed) may significantly influence the choice of appropriate actions. Local regulations may also prescribe or limit actions to be taken. Concentration of H2S in tank/container headspaces may reach hazardous values, especially in case of prolonged storage. As H2S has a density greater than ambient air, a possible exception may regard the build-up of dangerous concentrations in specific spots, like trenches, depressions or confined spaces. This situation is especially relevant for those operations which involve direct exposure to the vapours in the interior of tanks or other confined spaces. In all these circumstances, however, the correct actions should be assessed on a case-by-case basis.

SECTION 7: Handling and storage

7.1. Precautions for safe handling

Precautions for safe handling

This material is combustible, but will not ignite readily. Provide adequate ventilation. Use adequate personal protective equipment as needed. Due to the extremely slippery nature of this material, more care than usual must be exercised in material handling practices to keep off all walking surfaces. Floors, walls and other surfaces in the hazard area must be cleaned regularly. Avoid release to the environment. Emptied containers can contain combustible product residues. Do not cut, weld, drill, burn or incinerate empty containers or drums, unless they have been drained and cleaned. The product may release Hydrogen Sulphide: a specific assessment of inhalation risks from the presence of hydrogen sulphide in tank headspaces, confined spaces, product residue, tank waste and waste water, and unintentional releases should be made to help determine controls appropriate to local circumstances. Before entering storage tanks and commencing any operation in a confined area (e.g. tunnels), carry out an adequate clean-up, and check the atmosphere for oxygen content, flammability, and the presence of sulphur compounds. Hygiene measures
