SECTION 4: First aid measures

4.1 Description of first aid measures

General information:	Take off contaminated clothing and wash it before reuse. In the event of persistent symptoms seek medical treatment.
In case of inhalation:	If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. Seek medical attention if problems persist.
