### 2.3. Other hazards (not relevant for classification)

Other hazards not contributing to the classification : This product is combustible, but not classified as Flammable. The creation of flammable vapour mixtures takes place at temperatures which are higher than normal ambient levels. If the product is handled or used at high temperature, contact with hot product or vapours may cause burns. Do not wait for symptoms to develop. Any substance, in case of accidents involving pressurized circuits and the like, may be accidentally injected under the skin, even without external damage. In such a case, the victim should be brought to a hospital as soon as possible, to get specialized medical treatment. In exceptional cases (i.e prolonged storage in tanks contaminated with water, and presence of anaerobic sulfate-reducing microbial colonies), the product may undergo a degradation and generate small amounts of sulfur compounds, including H<sub>2</sub>S.

## SECTION 4: First aid measures

### 4.1. Description of first aid measures

First-aid measures after inhalation : In case of disturbances owing to inhalation of vapours or mists, remove the victim from exposure; keep at rest; if necessary, seek medical attention. See also section 4.3.

First-aid measures after skin contact : Take off contaminated clothing and shoes. Wash thoroughly with soap and water. If inflammation or irritation persists, seek medical advice. In case of contact with hot product, cool affected part with plenty of cold water, and cover with gauze or clean cloth. Call a doctor or bring to a hospital. Do not use salves or ointments, unless directed by doctor. Do not put ice on the burn.

First-aid measures after eye contact : Rinse eyes thoroughly for at least 15 minutes. Keep eyelids well apart. If irritation persists, seek medical advice. In case of contact with hot product, cool affected part with plenty of cold water, and cover with gauze or clean cloth. Call a doctor or bring to a hospital. Do not use salves or ointments, unless directed by doctor.

First-aid measures after ingestion : Do not induce vomiting to avoid aspiration into the lungs. If the person is conscious, rinse mouth with water without swallowing. Keep at rest. Call for medical assistance or bring to a hospital. If the casualty is unconscious, place in the recovery position. In case of spontaneous vomiting, keep head low, to avoid the risk of aspiration into the lungs. Do not give anything by mouth to an unconscious person.

### 4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects after inhalation : This product has a low vapour pressure, and in normal conditions at ambient temperature the concentration in the air is negligible. A significant concentration may build up only if the product is used at high temperature, or in case of sprays and mists. In these cases overexposure to vapours may cause irritation to airways, nausea and dizziness.

Symptoms/effects after skin contact : Contact with hot product may cause thermal burns.

Symptoms/effects after eye contact	: Contact with eyes may cause a light transient irritation. Contact with hot product or vapours may cause burns.
Symptoms/effects after ingestion	: Accidental ingestion of small quantities of the product may cause irritation, nausea and gastric disturbances. Taking into account the taste of the product, however, ingestion of dangerous quantities is very unlikely.
Symptoms/effects upon intravenous administration	: No information available.
Chronic symptoms	: None to be reported, according to the present classification criteria.

### 4.3. Indication of any immediate medical attention and special treatment needed

Obtain medical attention if casualty has an altered state of consciousness or if symptoms do not resolve. Seek medical attention in all cases of serious burns. If there is any suspicion of inhalation of H<sub>2</sub>S (hydrogen sulphide). The casualty should be sent immediately to hospital. Immediately begin artificial respiration if breathing has ceased. Administer oxygen if necessary.

## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

Suitable extinguishing media	: Small-size fires: carbon dioxide, dry chemicals, foam, sand or earth. Large fires: foam or water fog (mist). These means should be used by trained personnel only. Other extinguishing gases (according to regulations).
Unsuitable extinguishing media	: Do not use water jets. They could cause splattering, and spread the fire. Simultaneous use of foam and water on the same surface is to be avoided as water destroys the foam.

### 5.2. Special hazards arising from the substance or mixture

Fire hazard	: This product is combustible, but not classed as flammable. The creation of flammable vapour mixtures takes place at temperatures which are higher than normal ambient levels."
Explosion hazard	: In case of losses from pressurized circuits, the sprays may form mists. Take into account that in this case the lower explosion limit for mists is about 45 g/m <sup>3</sup> of air.
Hazardous decomposition products in case of fire	: Incomplete combustion will generate poisonous carbon monoxide, carbon dioxide and other toxic gases. Combustion products include sulphur oxides (SO <sub>2</sub> and SO <sub>3</sub> ) and Hydrogen sulphide H <sub>2</sub> S. Oxygenated compounds (aldehydes, etc.).

### 5.3. Advice for firefighters

Firefighting instructions	: Shut off source of product, if possible. If possible, move containers and drums away from danger area. Spilled product which is not burning should be covered with sand or foam. Use water sprays to cool containers and surfaces exposed to the flames. If the fire cannot be controlled, evacuate area.
Special protective equipment for firefighters	: Personal protection equipment for firefighters (see also sect. 8). #### 6.1.1. For non-emergency personnel

Emergency procedures	: Keep non-involved personnel away from the area of spillage. Alert emergency personnel. Except in case of small spillages, the feasibility of any actions should always be assessed and advised, if possible, by a trained, competent person in charge of managing the emergency.

#### 6.1.2. For emergency responders

Protective equipment	: Small spillages: normal antistatic working clothes are usually adequate. Large spillages: full body suit of chemically resistant and antistatic material. if necessary heat resistant and insulated. Work gloves providing adequate chemical resistance, specifically to aromatic hydrocarbons. Gloves made of PVA are not water-resistant, and are not suitable for emergency use. If contact with hot product is possible or anticipated, gloves should be heat-resistant and thermally insulated. Antistatic non-skid safety shoes or boots, chemical resistant, if necessary heat resistant and insulated. Work helmet. ### 6.2. Environmental precautions

Do not let the product accumulate in confined or underground spaces. Do not let the product flow into sewers or water courses, or in any way contaminate the environment. In case of contamination of environment compartments (soil, subsoil, surface or underground waters), remove contaminated soil when possible, and in any case treat all involved compartments in accordance with local regulations. The site should have a spill plan to ensure that adequate safeguards are in place to minimize the impact of episodic releases.

### 6.3. Methods and material for containment and cleaning up

- For containment : Contain spilled liquid with sand, earth or other suitable absorbents (non-flammable). Recover free liquid and waste materials in suitable waterproof and oil-resistant containers. Clean contaminated area. Dispose of according to local regulations. If in water: Confine the spillage. Remove from surface by skimming or suitable floating absorbents. Collect recovered product and other waste materials in suitable waterproof, oil resistant containers. Recover or dispose of according to local regulations. Do not use solvents or dispersants, unless specifically advised by an expert, and, if required, approved by local authorities.
- Other information : Recommended measures are based on the most likely spillage scenarios for this material; however, local conditions (wind, air temperature, wave/current direction and speed) may significantly influence the choice of appropriate actions. Local regulations may also prescribe or limit actions to be taken. For this reason, local experts should be consulted when necessary.

## SECTION 7: Handling and storage

### 7.1. Precautions for safe handling

- Precautions for safe handling : Ensure that all relevant regulations regarding handling and storage facilities of flammable products are followed. Do not use compressed air for filling, discharging, or handling operations. Keep away from heat/sparks/open flames/hot surfaces. Use and store only outdoors or in a well-ventilated area. During transfer and mixing operations, ensure that all equipment is correctly grounded. Avoid the build-up of electric charges. Emptied containers can contain combustible product residues. Do not cut, weld, drill, burn or incinerate empty containers or drums, unless they have been drained and cleaned. Before entering storage tanks and commencing any operation in a confined area (e.g. tunnels), carry out an adequate clean-up, and check the atmosphere for oxygen content, flammability, and the presence of sulphur compounds. - Hygiene measures : Avoid contact with skin. Do not breathe fume/ mist/ vapours. Do not ingest. Do not smoke. Do not eat and do not drink during use. Do not clean hands with dirty or oil-soaked rags. Do not use clothes, if they are still contaminated. Keep away from food and beverages. Take off immediately all contaminated clothing and wash it before reuse. Contaminated materials should not be allowed to accumulate in the workplaces and should never be kept inside the pockets. Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work.

### 7.2. Conditions for safe storage, including any incompatibilities

- Storage conditions : Store in dry, well ventilated area. Keep away from open flames, hot surfaces and sources of ignition. Do not smoke.

Note : The Derived No Effect Level (DNEL) is an estimated safe level of exposure that is derived from toxicity data in accord with specific guidance within the European REACH regulation. The DNEL may differ from an Occupational Exposure Limit (OEL) for the same chemical. OELs may be recommended by an individual company, a governmental regulatory body or an expert organization, such as the Scientific Committee for Occupational Exposure Limits (SCOEL) or the American Conference of Governmental Industrial Hygienists (ACGIH). OELs are considered to be safe exposure levels for a typical worker in an occupational setting for an 8-hour work shift, 40 hour work week, as a time weighted average (TWA) or a 15 minute short-term exposure limit (STEL). ## 8.2. Exposure controls

### Appropriate engineering controls:

### Personal protective equipment (for industrial or professional use):

Face shield. Gloves. Protective clothing. Safety glasses. Safety shoes or boots. Dust/aerosol mask.

### Hand protection:

When there is a risk of contact with the skin, use hydrocarbon-resistant, felt-lined gloves. Adequate materials: nitrile (NBR) or PVC with a protection index > 5 (permeation time > 240 mins). Use gloves respecting all the conditions and within the limits set by the manufacturer. Replace gloves immediately in case of cuts, holes or other signs of damages or degradation. If necessary, refer to the EN 374 standard.

### Eye protection:

When there is a risk of contact with the eyes, use safety goggles or other means of protection (face shield). If necessary, refer to national standards or to the EN 166 standard.

### Skin and body protection:

Long-sleeved overalls. If necessary, refer to the EN 340 and related standards, for definition of characteristics and performance according to the risk rating of the area. Antistatic non-skid safety shoes or boots, chemical resistant, if necessary heat resistant and insulated.

### Respiratory protection:

Independently from other possible actions (technical modifications, operating procedures, and other means to limit the exposure of workers), personal protection equipment can be used according to necessity.
