SECTION 4: First aid measures

Description of first aid measures

First-aid measures after inhalation

: In case of disturbances owing to inhalation of vapours or mists, remove the victim from exposure; keep at rest; if necessary, seek medical attention. If casualty is unconscious and not breathing: ensure that there is no obstruction to breathing and give artificial respiration by trained personnel. If necessary, give external cardiac massage and obtain medical advice. If the casualty is breathing: Place in the recovery position. Administer oxygen if necessary.

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

General measures

: Stop or contain leak at the source, if safe to do so. Eliminate all ignition sources if safe to do so (e.g. electricity, sparks, fires, flares). Avoid accidental sprays on hot surfaces or electrical contacts. Avoid direct contact with released material. Keep upwind.

6.1.1. For non-emergency personnel

Emergency procedures

: Keep non-involved personnel away from the area of spillage. Alert emergency personnel. Except in case of small spillages, the feasibility of any actions should always be assessed and advised, if possible, by a trained, competent person in charge of managing the emergency.

6.2. Environmental precautions

Clear spills immediately. Prevent product from entering sewers, rivers or other bodies of water. In case of contamination of environment compartments (soil, subsoil, surface or underground waters), remove contaminated soil when possible, and in any case treat all involved compartments in accordance with local regulations. The site should have a spill plan to ensure that adequate safeguards are in place to minimize the impact of episodic releases.

6.3. Methods and material for containment and cleaning up

For containment

: Confine the spillage. Remove from surface by skimming or suitable absorbents. Collect recovered product and other materials in suitable waterproof containers. Notify local authorities according to regulations. If necessary dike the product with dry earth, sand or similar non-combustible materials. When inside buildings or confined spaces, ensure adequate ventilation. Absorb spilled product with suitable non-combustible materials. Collect free liquid and waste materials in suitable waterproof and oil resistant containers. Clean the contaminated area. Dispose of in accordance with relevant local regulations. Do not use solvents or dispersants, unless specifically advised by an expert, and, if required, approved by local authorities.

Note	: The Derived No Effect Level (DNEL) is an estimated safe level of exposure that is derived from toxicity data in accord with specific guidance within the European REACH regulation.
